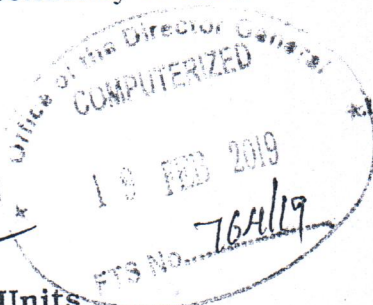
This is in reference to a meeting held on 05.02.2019 in the Cabinet Secretariat regarding court cases and their updation on Legal Information Management & Briefing System (LIMBS).

2. In the above context, all the Media Units and divisions concerned are requested to make concerted efforts to reduce the pendency of cases in various Courts at the earliest. There can be several measures for reducing pendency including clubbing similar cases, taking the policy decisions on users which are being litigated time and again, etc. As there may be avoidable cases pertaining to the personnel matters, the divisions concerned may take up the issue with DoPT for policy intervention.

3. The Media Units and divisions concerned may also mandatorily ensure regular updation of details of all Court Cases on LIMBS. LIMBS portal also has a feature of processing the bills of advocates and can be utilized for timely payment of bills by the users. Very few users have started processing the bills on the module. The archiving process; for old completed cases, needs to be reviewed by the divisions concerned. The analysis may be done based on the age of the pendency of case.
