ALL HEAD OF OFFICES ARE HEREBY INSTUCTED TO TAKE IMMEDIATE MEASURES TO ENSURE ROBUST PHYSICAL SECURITY, STRICT ACCESS CONTROL, CCTV SYSTEM, FRISKING OF ALL ENTRANTS IN THEIR RESPECTIVE INSTALLATIONS AND THOROUGH CHECKING OF ALL VEHICLES ENTERING AND MOVING OUT FROM DD PREMISES TO PREVENT ANY UNTOWARD INCIDENTS (.) ALL HEADS OF OFFICES ARE ALSO TO CARRYOUT NECESSARY LIAISON WITH LOCAL ADMINISTRATION (DISTRICT MAGISTRATE AND SUPDT OF POLICE) TO ENSURE THAT NECESSARY SECURITY COVER FOR DOORDARSHAN INSTALLATIONS IS PROVIDED BY THE STATE AUTHORITIES (.)

(BRAVO) ALL HOOS OF CAPITAL STATIONS WILL BE THE NODAL OFFICERS OF RESPECTIVE STATES AND LIAISE WITH CHIEF SECRETARIES OF THE STATE/CONCERNED AUTHORITIES OF THE STATE TO ENSURE ADEQUATE SECURITY COVER IS MADE AVAILABLE TO DOORDARSHAN INSTALLATIONS DURING THIS CURRENT PERIOD OF HIGH ALERT (.) ALL STATIONS TO FORWARD COMPLETION REPORT TO THE DIRECTORATE BY 05 MARCH 2019 (.) ANY UNTOWARD INCIDENTS RELATING TO THE SECURITY WILL IMMIDIATELY BE INFORMED TO THE RESPECTIVE ADG PROGRAMME AND ENGINEERING WITHOUT ANY DELAY (.) AN INCIDENT REPORT GIVING DETAILS OF INCIDENT, TIME AND DATE AND PLACE OF INCIDENT WILL ALSO BE FORWARDED WITHIN 24 HRS OF THE INCIDENT TO RESPECTIVE ADG BOTH PROGRAMME AND ENGINEERING AND COPY TO DDG (ADMIN AND SECURITY) (.)
