- All such advertisements can only be booked directly with Doordarshan Marketing/Commercial offices and are not allowed for telecast in the FCT of the sponsored programmes of various producers. This means sponsored programme producers/their marketing agencies cannot book such advertisements in their FCT.
- All such advertisements/commercials would clearly have supered on them for the complete duration of the advertisements "policical campaign advertisements" or "Chunay Prachar Vigyapan".
